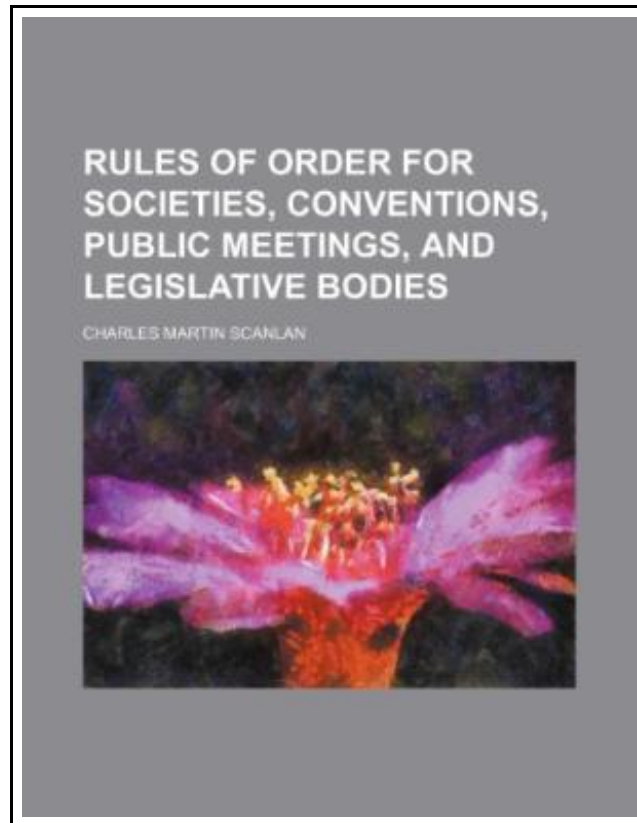

Adjourn. --A motion to adjourn when the time of the next meeting is fixed, is a privileged question and always in order excepting when a member is speaking, or a point of order or an appeal that is not debatable is before the house, or a vote is being taken, or a similar motion has just been defeated. A motion to reconsider another question may be made and entered in the record, but no further action can be taken thereon when a motion to adjourn is before the house. The motion to adjourn is not debatable, and cannot be amended, laid on the table, committed, postponed, reconsidered, or made ADJOURN, QUORUM. 59 in a committee of the whole. If the motion to adjourn is defeated, there must be some intervening business done before the Chair will receive another motion to adjourn. The motion is simply to adjourn. If it is qualified by adding a time, it is a main question. Every question that permits of discussion is subject to the motion to adjourn. The discussion may be resumed at the next meeting. Less than a quorum may adjourn, and when there are regular meetings to be held daily, may adjourn from day to day, but otherwise cannot fix a time to which to adjourn, and cannot do any other business. If the time to adjourn is fixed, when it arrives the chairman may adjourn the meeting without a motion....
